I, the undersigned parent/student, agree to complete the indicated course of instruction by the Safe America Foundation Driving School (hereafter, the "School") for the fee as indicated above. It is understood that the School is licensed by the Georgia Department of Driver Services (DDS) in accordance with Georgia Law Title 43-13-1 (The Driver Training School and Commercial Driving Training School License Act) and that each instructor has been certified by the Georgia Department of Driver Services.

I understand that the School will not refund any tuition, or part of tuition, if the School is ready, willing and able to fulfill its part of this contract. I understand that if I fail to comply with the terms and conditions of this Agreement, I am in breach of contract and the School will be under no obligation to fulfill the terms of this contract and may, at its option, terminate this Agreement immediately. Instruction must be completed within six (6) months of the date of this contract.

I understand that the successful completion of the course indicated above does not entitle me to receive a motor vehicle operator's license nor guarantee that I will be successful in completing the requirements for obtaining a driver's license from Georgia or any other state. However, immediately upon successful completion of the 30/10, 30/6 or 30-hour classroom only course, the School agrees to provide certification of said completion to the student if the required minimum hours have been completed.

The School has and will maintain, for the protection of the contractual rights of the student, a performance bond in the principal sum of Ten Thousand (\$10,000.00) Dollars to be written by a company authorized to do business in the State of Georgia.

## CANCELLATION POLICY

Cancellations made fourteen (14) calendar days or more prior to the first classroom instruction date will receive a full refund of tuition paid, less a \$75.00 processing fee. Cancellations 7 to 13 calendar days prior to the first classroom instruction date will receive 75% refund. Cancellations made less than seven (7) calendar days prior to the first classroom instruction date will forfeit the paid tuition and will not be able to transfer this enrollment to any other session.

Behind-the-Wheel Training Cancellation Policy: Appointments must be cancelled at least twenty-four (24) hours in advance or the student forfeits the session and any fees associated with the session. When a student is ten (10) minutes or more late for a driving session, the session may be rescheduled at the instructor's convenience and the student assessed additional fees. Make-up sessions are assessed a \$40.00 charge. Make-up sessions must be completed within sixty (60) days from previous session. No refund is given for missed sessions and hours are not transferable between students. Missed time will not be refunded. No behind-the-wheel driving instruction will be given in hazardous weather.

By signing this Agreement, I acknowledge that I have received, read and understood the rules and cancellation policy of the School. Any violation of any rules or regulations will result in forfeiture of scheduled time and fees.

***Every student/parent/guardian agrees to the following conditions:***

- 1) All fees must be paid before beginning any training course, unless otherwise noted.
- 2) A \$30.00 fee will be charged for any returned checks or disputed charges.
- 3) A course must have a minimum of eight (8) students enrolled to hold class. In the event a scheduled course has to be cancelled, the student will be rescheduled for another course.
- 4) Attendance for all thirty (30) hours of classroom instruction is required for successful completion of the full driver training course. Absences must be made up. Any student missing more than eight (8) hours of the scheduled thirty (30) hours of classroom instruction will be required to repeat the entire course at the next-scheduled session. An additional fee of \$50.00 will be assessed.
- 5) Completion of a written or oral examination with a grade of at least seventy (70%) percent for the in-class instruction and/or driving session is required for successful completion of the course or portion thereof.
- 6) The student must present a valid Georgia permit or license to begin the behind-the-wheel driving segment.
- 7) Each supervised driving session must consist of a minimum of two (2) hours, commencing at a scheduled time. The student may extend the time at an additional cost if agreed in advance.
- 8) No passengers, snacks, cell phones, cameras, radios or other related electronic devices are allowed during behind-the-wheel instruction.
- 9) The parent/student releases the School, its agents or employees, from all liability, including traffic violations, injury, damages or claims which the student may suffer or incur arising out of any act, restriction or omission in the Driver Education Program, except by reason of gross negligence of such persons.
- 10) The student understands that he/she may drive an automobile or any motorized automobile ONLY when under the supervision of the instructor licensed to teach Driver Education and ONLY while participating in an authorized Driver Education Program. The student further understands that ONLY he/she may drive the automobile and he/she may not grant permission to others.
- 11) Traffic violations are the responsibility of the student and his/her actions. Student will not hold the School or its agents responsible for any traffic violation during highway instruction.
- 12) Any type of behavioral problem will result in dismissal from the course and the full tuition will be forfeited.

***The Safe America Driving School agrees to the following conditions:***

- 1) To provide use of a School vehicle for the actual driving instruction without additional cost.
- 2) To begin and end the driving segments at the location of the classroom instruction.
- 3) To maintain insurance to protect the student.

This Agreement constitutes the complete contract between the School and the parent/guardian and no verbal statements will be recognized.
